What is a community-led plan?

It is a document which sets out a vision for your community's future, based on sound local research carried out by the community itself. It highlights important issues and the projects which need to be tackled.

Why do a parish or community-led plan?

- To get people involved and talking to each other
- To provide evidence of local need
- To highlight new projects
- To identify skills of residents
- To influence and inform others

What are the main stages in producing the plan?

- Setting up a team of people from the community to manage the process
- Undertaking a variety of consultations to gather opinions from as many people in the community as possible
- Using the results to produce a realistic action plan
