### **Coronavirus:**

#### **Legionella, Government's Job Retention Scheme, Charity Commission Guidance and More Grants**

This edition reminds those responsible for premises about Legionella, provides links to the government's Job Retention Scheme and Charity Commission guidance for charities and gives outlines of more grants.

#### **Legionella – a reminder for village halls and other premises**

**A reminder - flushing water systems at least once a month while closed and then a thorough flushing through of everything before re-opening, with particular attention to a system serving any showers, will help avoid the risk of Legionella.**

Legionnaires' disease is a potentially fatal pneumonia caused by Legionella bacteria. It tends to be associated with larger water systems (such as hotels, hospitals and cooling towers) but can live in smaller water supply systems.

Under health & safety legislation anyone responsible for premises must consider the risks from legionella that may affect staff or members of the public and take suitable precautions.

Regular throughput of water in the cold water systems of many village halls and community buildings will reduce the risk. However, some buildings may have hot water cylinders and distribution pipework which will need to be considered against factors known to increase the risk. These factors include water temperature, where water is dispersed over a wide area as with showers, infrequently used outlets such as disused taps and the presence of sludge, rust, algae or organic matter.

#### **Government's Coronavirus Job Retention Scheme**

If you cannot maintain your current workforce because your operations have been severely affected by coronavirus (COVID-19), you can furlough employees and apply for a grant that covers 80% of their usual monthly wage costs. In place for four months from 01 March, but might be extended.

Claim - up to £2,500 a month, plus the associated Employer NI and pension contributions to the level of the minimum automatic enrolment employer pension contribution on that subsidised pay.

For community and voluntary groups (constituted and un-constituted), CICs and registered charities incurring additional costs due to this response and to support innovative grassroots projects.

Grants – up to £1,000.

## **COVID-19 Homeless Support Fund – Morrisons Foundation**

A £500,000 fund to support registered charities caring for the homeless during the coronavirus outbreak.

Grants – up to £10,000.

Applications will be considered on a weekly basis and accepted until the fund is depleted, after which time homeless charities are still welcome to submit applications for support, but will be considered through the established grant funding process.

## **The Antonio Carluccio Foundation Grant**

A grant budget of £500,000 in response to the Covid-19 crisis - for registered charities in the UK and Italy working to feed those in need and promote a better understanding of food origins and nutrition.

Grants – up to £10,000.

Grants are for:

- projects which feed those who are suffering poverty and/or malnutrition
- projects which seek to educate those suffering poverty and/or malnutrition in a way they can apply that knowledge to feed themselves and others in a healthy, sustainable manner
- projects and individuals undertaking training of chefs and cooks

## **Scottish & Southern Electricity Networks – Resilient Communities Fund**

## **National Lottery Community Fund**

NLCF will continue to honour its current commitments and be flexible with existing grants. However, all funding decisions made for the next six months will prioritise getting funding to groups best placed to support their communities during the crisis. Priority will be given to organisations:

- supporting communities most likely to face increased demand and challenges as a direct result of COVID-19

## **Waste and Resource Action Programme (WRAP) in collaboration with government**

For not-for-profit food redistributors who are currently running a food redistribution operation in England and which can redistribute surplus food from retailers, wholesalers and food manufacturers to people in need.

**Phase 2** for micro and small food redistributors – closes 4<sup>th</sup> June or earlier if fully allocated.

Grant - £5,000 to £10,000.

**Phase 3** for medium to large scale operations - closes 21<sup>st</sup> May 2020 or earlier if fully allocated.

Grant – up to £50,000.

## **Coronavirus Mental Health Response Fund**

Administered by Mind.

For mental health voluntary sector organisations based in England to respond to anticipated increase in need as a direct result of the Coronavirus pandemic.

Small grant – up to £20,000.

Large grant – up to £50,000 (£100,000 will be considered if working across three or more English regions).
