About the role

The successful candidate will need to work across Tewkesbury Borough, with a range of partners, identifying and assessing Affordable Housing need. The role would suit an experienced Housing Enabler or planning professional to develop their understanding of Affordable Housing development.

Main Tasks

- Work as a neutral, independent partner to encourage and assist Parish Councils and communities, providing options and choices for how communities can address their Affordable Housing needs, including taking a Community Led approach.
- Identify housing need using different methods including geography-based Housing Needs Surveys for Affordable and Community Led Housing provision, interpret the results, write reports, and share these with the appropriate communities and partners.
- Support rural Affordable Housing projects through direct 1-2-1 support and partnership working
- Source suitable sites for development, engage landowners (including Rural Exception Sites).

- Provide an initial site assessment for affordable housing projects for Local Authority planning officers
- Undertake community consultation on sites necessary to help bring projects forward.
- identify, engage with and work in partnership with Registered Providers and other developers for affordable housing delivery as sites are identified
- Act as a broker / single point of contact for the progression of projects between communities, Parish / Town Councils, landowners, and Gloucestershire Rural Housing Partnership (GRHP) partners including registered providers.
- Provide feedback and commentary on any Affordable Housing planning applications to local Planning Officers including Section 106 agreements.
- Provide regular pipeline monitoring reports, aligned to funding requirements, and as required by the Rural Housing Partnership or RHE Steering / Advisory Group to inform prioritisation of RHE activity.
- · Raise the profile of Affordable Housing to those in housing need through direct community engagement, elected members and other partners.
- Work closely with Local Planning Authority and Local Housing Authority officers to develop planning policy and strategies, overcoming barriers to enable the delivering of rural Affordable Housing.
- Enable the voice and engagement of those in Affordable Housing Need to be participative in the planning system and process.
- Be an independent facilitator at networks and community consultation events, delivering presentations, workshops, training, and learning for communities and other RHE delivery partners.
- Contribute to and attend meetings of Gloucestershire Rural Housing Partnership.
- Link into and support Community Led Planning
- Engage with key strategic bodies in Gloucestershire who also have Affordable Housing as part of their work plan and strategy development, such as health and wellbeing partners.
- Work strategically, engaging with other Affordable Housing delivery partners such as Homes England, Ministry Housing, Communities and Local Government, land owners, private developers, and urban Housing Associations, elected members, and economic partners to promote the hub for Affordable Housing.
- As RHE (TBC), contribute to the monitoring and evaluation of the progress of Rural Housing Enabling in Gloucestershire.
- Identify and engage volunteer 'Affordable Housing Champions' in the Borough.
